

## Mandatory Waiver and Release of Liability - Read Before Agreeing

I hereby acknowledge that I am voluntarily participating in sports activities organized and/or under the cognizance of the TriCounty Baseball League. I understand that these activities involve inherent risks, including but not limited to bodily injury, illness, property damage, etc. and death, which may occur as a result of my participation. Therefore, I agree at my own free will to the following terms:

- 1. RELEASE AND WAIVER OF LIABILITY I hereby release and forever discharge the TriCounty Baseball League, its directors, officers, agents, employees, and volunteers (collectively, the "Released Parties"), from any and all liability, claims, demands, and causes of action that I may have now or in the future, arising out of or related to any loss, bodily injury, illness, property damage, etc. including death, that may be sustained by me or to any property belonging to me, whether caused by the negligence of the Released Parties or otherwise.
- **2. ASSUMPTION OF RISK** I understand and acknowledge that my participation in the sports activities organized and/or under the cognizance of the TriCounty Baseball League involves inherent risks, including but not limited to bodily injury, illness, property damage, etc. and death. I voluntarily assume all risks associated with my participation in these activities.
- **3. INDEMNIFICATION** I agree to indemnify, defend, and hold harmless the Released Parties from any and all claims, demands, and causes of action, including attorneys' and/or other related fees and costs, etc. arising out of or related to my participation in the sports activities organized and/or under the cognizance of the TriCounty Baseball League.
- **4. MEDICAL INSURANCE** I understand that medical insurance provided by the TriCounty Baseball League is excess coverage and is secondary in nature, and my primary health insurance required by federal law will be the primary source of health insurance. I also assume full responsibility for any and all deductibles and/or co-pays, non-covered items, costs, etc.
- **5. ACKNOWLEDGEMENT OF UNDERSTANDING** I have read this sports waiver, fully understand its terms, and understand that I am relinquishing at my own free will substantial rights, including my right to legal liability (sue) the Released Parties for any bodily injury, illness, property damage, etc. and death that may result from my participation in the sports activities organized and/or under the cognizance of the TriCounty Baseball League.
